



Pre-booking Terms & Conditions

1. The following group of customers are eligible to book:
 - a. Customers who are over eighteen (18) years of age.
 - b. Customers who **do not have** outstanding payments due over forty five (45) days.
 - c. Customers who **do not have** two (2) or more existing contracts with Maxis.
 - d. Customers who **have**
 - i. One (1) existing contract with Maxis with over two (2) remaining months to fulfill a twelve (12) months contract **OR**
 - ii. One (1) existing contract with Maxis with over four (4) remaining months to fulfill a twenty four (24) months contract
 - e. Current Maxis postpaid principal line subscribers. Supplementary Plan and Corporate Plan customers are not eligible.
2. Customers must sign a twelve (12) or twenty four (24) months contract (NEW or re-contracted) on any of the following:
 - a. iValue Plans (iValue 1, 2, 3 or 4)
 - b. Value Plans (Value Plan 50, 80, 150, 250 or 500) with iData offers
 - c. Value Plus Plans (Value Plus 50, 80, 150 or 250) with iData offers
 - d. Family Plus Plan (Family Plus 30 or 50) with iData offers
 - e. Family Plan (Family Plan 30 or 50) with iData offers
3. For customers purchasing the iPhone 3G S together with a new subscription contract, any subsequent handset iPhone upgrade shall only be permitted no earlier than twelve (12) months prior to expiry of the said subscription contract.
4. Only an upgrade of a price plan is allowed. In the circumstance where the customer nevertheless decides to opt for a downgrade of a price plan or for termination of lines less than the relevant commitment periods under eligible plans of twelve (12), or twenty four (24) months contract, early termination charges shall apply.

 - (a) Booking of the iPhone 3GS begins on 15th July 2009 and ends on 7th August 2009 and is only confirmed when the customer makes payment of a non-refundable deposit of Ringgit Malaysia Two Hundred (RM200.00) ("Deposit").
 - (b) To confirm an online booking registration, payment of the Deposit shall be made within five (5) days from your booking submission date or 7th August 2009, whichever is earlier.
 - (c) Each customer with a confirmed booking shall be given a period of fourteen (14) days from the date of notification by Maxis to collect their iPhone 3G S. The Deposit shall be forfeited if the customer cancels his/her booking after payment of the Deposit is made or if the customer does not

collect his/her booked iPhone 3G S within fourteen (14) days from his/her confirmed booking.

(d) The Deposit shall be deducted from the actual price of the iPhone 3G S or where the iPhone 3G S unit price is less than RM200.00 (for the 8GB and 16GB iPhone 3G S model, iPhone 3G S under iValue 4 twenty four (24) months contract), the Deposit will be rebated to the Customer's phone bill.

(e) Dates provided on the online booking registration is subject to changes, depending on demand and stock availability and as and when deemed necessary by Maxis.

6. Each person is only entitled to book a maximum of two (2) iPhone 3G S units i.e. a customer can only hold a maximum of two (2) phone contracts at a time. Therefore each NRIC/Passport/Police/Military no. will only be allowed two (2) bookings.
7. Maxis shall not be liable for cases such as the non-availability of the iPhone 3G S or non-approval of the iPhone 3G S or any other cause resulting in the iPhone 3G S not being made available for sale in Malaysia. Maxis reserves the right to amend these terms and conditions without notice in such manner as Maxis deems appropriate. These terms and conditions shall be subjected to and construed in accordance with the laws of Malaysia.
